Dear Craftsperson,

We are pleased that you are interested in joining us for the November season. We will have four Arts & Crafts Saturdays joining our Farmers' Market in November. The market opens **rain or shine** every Saturday in November. The season will close after the November 27th market.

You must furnish everything you need to be comfortable and dry.....in other words, have an umbrella, and wear warm, water-proof clothes. You will have one parking space (9 feet wide) in which to set up your table. Usually everyone keeps their vehicle within their allotted space, rather than parking it elsewhere. If you have a friend coming to help, or choose to park outside of your stall space, please park all vehicles on Vine Street, and leave nearby parking for customers.

The following rules of our market are applicable to everyone. You must read them and consent to following them by signing the craft application.

Rules:

1. All prices will be clearly posted.
2. No selling of any item until market officially opens (with the 9 A.M. ringing of the bell).
3. Sellers must maintain their stall space in a clean and sanitary condition.
4. Any seller not at their stall space 30 minutes BEFORE the opening of market will park at the edge of the market and NOT drive into the market. **Please arrive before 8:30.**
5. Sellers may NOT move their vehicle within the market until the market is over AND it is safe to do so.
6. Sellers have the responsibility for the safety and behavior of their own children.

7. NO DOGS ALLOWED IN THE MARKET.

8. Lavatory facilities with hot water are available for market sellers. They located in the Hotel Healdsburg adjacent to the market across the creek bridge.

9. Sellers, consumers, and management are expected to maintain high standards of honesty and to conduct themselves at all times in a courteous and helpful manner. Unreasonable or outrageous behavior is grounds for suspension from the market.

10. Stall fee is 10 per cent of total daily gross with a **minimum of \$20 dollars** and a maximum fee of \$30.00. There is also an advance application fee of \$30 dollars.

11. The art or craft must be an original creation. No peddling allowed.

12. The HCFM reserves the right to deny permission to sell at their site any item deemed inappropriate by the majority of the HCFM Board of Directors.

13. We prefer that you bring market umbrellas rather than canopies, unless rain is falling and a canopy is essential. If you plan to bring a pop-up canopy, please notify the manager ahead of time and provide the dimensions of the canopy. Vendors with canopies will be lined up with other vendors with canopies so that vendors with market umbrellas will not be squeezed out.

14. Coffee is provided by the Jintown Store after 8am.

15. If you have never been to the market before, please plan to arrive no later than 8 AM.
