TWO MARKETS:

The Saturday Market is May 4th – November 30th, 8:30 – noon in the West Plaza Parking Lot behind Bear Republic

The Tuesday Market is May 28th – September 24th, 9am – 1pm on the Plaza, downtown

This is the market's 41st year, being one of the original 22 farmers' markets in California! A jewel of Sonoma County, it has some of the area's most cherished farms as its vendors, along with delicious food products, fresh meats, seafood, baked goods, condiments, sweets and beautiful craft. A majority of our vendors grow or produce within 20 miles of the market. We allow no commercial vendors, and have a limited amount of non-profit booths each week. Healdsburg locals love their market and support it.

APPLYING TO THE MARKET:

THERE ARE TWO APPLICATION FORMS; ONE FOR EACH MARKET. If you are a current vendor please get your application in ASAP. If you've never done the market, or haven't done it in recent years, first priority is given to current vendors, but we do have space available for vendors who meet the needs of the market.

IF YOU HAVE NEVER APPLIED, AND WERE NOT ASKED TO APPLY BY THE MANAGER, PLEASE CONTACT US FIRST TO SEE IF YOU'RE GOODS ARE NEEDED AT THE MARKET. Application fees are not refundable, so if you randomly apply and we don't need you, you lose the money. If we don't have space for you when you apply we may, at the manager's discretion, put you on a Waiting List.

SELECTION OF VENDORS IS DETERMINED BY:

- 1) SENIORITY
- 2) OVERALL BALANCE OF PRODUCTS AT MARKET
- 3) LOCALLY GROWN/MADE PRODUCTS
- 4) COMPLIANCE WITH ALL THE RULES AND REGS OF THE MARKET, DEPT OF AG, SAFETY AND INSURANCE REQUIREMENTS, AND ANY OTHER STATE/COUNTY REGULATIONS WHICH APPLY
- 5) SEASONAL AVAILABILITY OF PRODUCE
- 6) FREQUENCY OF ATTENDANCE

APPLICATION FEE: \$30 PER SEASON DUE 4/1/19. AFTER THIS DATE THE FEE GOES UP TO \$45 PER SEASON.

This fee is for both markets. Even if you are just doing a few markets during the run you must pay the full application fee.

WEEKLY FEES SATURDAYS: 10X10 SPACE: \$30 ~ 10x20 SPACE: \$50 ~ CORNER BOOTH: add \$10

WEEKLY FEES TUESDAYS: 10% OF SALES UP TO \$30 ~ DOUBLE BOOTH \$15/WEEK ADDITIONAL

Additionally a CDFA weekly fee of \$2.00 will be charged to every vendor.

NOTIFICATION: You will be notified of acceptance within a week of deadline. You will be sent final set-up information and booth assignments by April 20th.

2019 APPLICATION CHECKLIST

- This checklist is to help you determine which documents (copies of required certificates, permits, etc.) must be in the market files by **April 1, 2019**.
- Requirements are subject to change pending city, state, county, or market determinations.

ALL VENDORS

- _____ **Completed and Signed Application Form**
- _____ **Filled in Questionnaire for the new Market Brochure**
- _____ **\$30 Application Fee (\$45 if after April 1, 2019) -Do not send cash.**
(Non-refundable check made out to HCFM)
- _____ **Copy of your CURRENT driver's license and that of any employee driving into the market**
- _____ **Copy of CURRENT proof of car insurance for all vehicles that will enter the market**
- _____ **Copy of your city of Healdsburg Business License (see link below)**

1. CERTIFIED AGRICULTURAL PRODUCERS

This category includes growers and producers of vegetables, fruits, nuts, honey, shell eggs, nursery stock, cut flowers

- _____ **Copy of Certified Producers Certificate (CPC) (see Sonoma Co Ag Comm link below)**
 - ***Please send a photocopy of your CPC at least 2 weeks before your first market date.***
 - ***Keep the embossed copy to conspicuously post at your stall every market day.***

Nurseries:

- _____ **Nursery License from Ag Office**
Allow six weeks for the County to get a signature from CDFA
- If your sales are less than \$1,000, you must have a Fee-Exempt Nursery License.
- If your sales are greater than \$1,000, you must pay a fee for a Nursery License
- _____ **California Sellers Permit (see SBE link below)**

Cut Flowers:

- _____ **Copy of Egg Handlers Permit with the Handler's Code assigned by the state. (see link below)**

Certified Agricultural Producers with Organic Certification

- _____ **Copy of Organic Registration (and Certification if Applicable)**

If your produce is grown organically, and you want to advertise "Organically Grown" to the public, then you must obtain Organic Registration with the State through the Ag. Office. If your gross sales are greater than \$5,000, then you must additionally obtain Organic Certification from CCOF or another organization. Your Organic Registration or Certification must be posted at your stall every market day.

2. NON-CERTIFIABLE AGRICULTURAL PRODUCERS

This category includes dairy, meat, preserves, olive oil

_____ Copy of County of Sonoma Dept. of Health Services, Retail Food Facility Permit (RFFP), or a letter with that Department's determination of which permits are needed to sell your product at a CFM. This includes vendors who prepare or process food in a certified home kitchen, as allowed under the Cottage Food Law. (see link below) ***Certified Producers (with a CPC) who have preserves or olive oil produced by a facility may provide the State Registration from that facility in lieu of the RFFP.***

_____ Copy of Product Liability Insurance -minimum \$1,000,000 coverage.
Only send Declarations Page, naming HCFM as additional insured.

3. NON-CERTIFIABLE NON-AGRICULTURAL PRODUCERS

This category includes all other prepared food, fish, sausage, PREPARED FOOD VENDORS

_____ Copy of County of Sonoma Dept. of Health Services, Retail Food Facility Permit (RFF) or Temporary Food Facility Permit (TFF) (see link below) Food vendors must have public health permits at point of sale.

_____ Copy of Product Liability Insurance-minimum \$1,000,000 coverage and HCFM named as additionally insured.
Only send Declarations Page, naming HCFM as additional insured (see attached sample)

_____ SBE Sellers permit. (see link below)

4. ARTS & CRAFTS

_____ SBE Sellers permit.(see link below)

_____ (New vendors only) 3 photos of your work/ 1 of your display

Notes for Arts & Crafts Vendors:

~Your work must be handmade by you, or domestically in small production. No imports or mass manufactured goods allowed.

~We have a small amount of craft each market, so set up a rotation and all vendors can have some dates during the season. Please indicate on the form all the dates you'd like and I'll fit you into a schedule.

~The month of November is our annual Craft Fair, so make sure to apply for the Saturdays that month as you can do all of them if desired.
